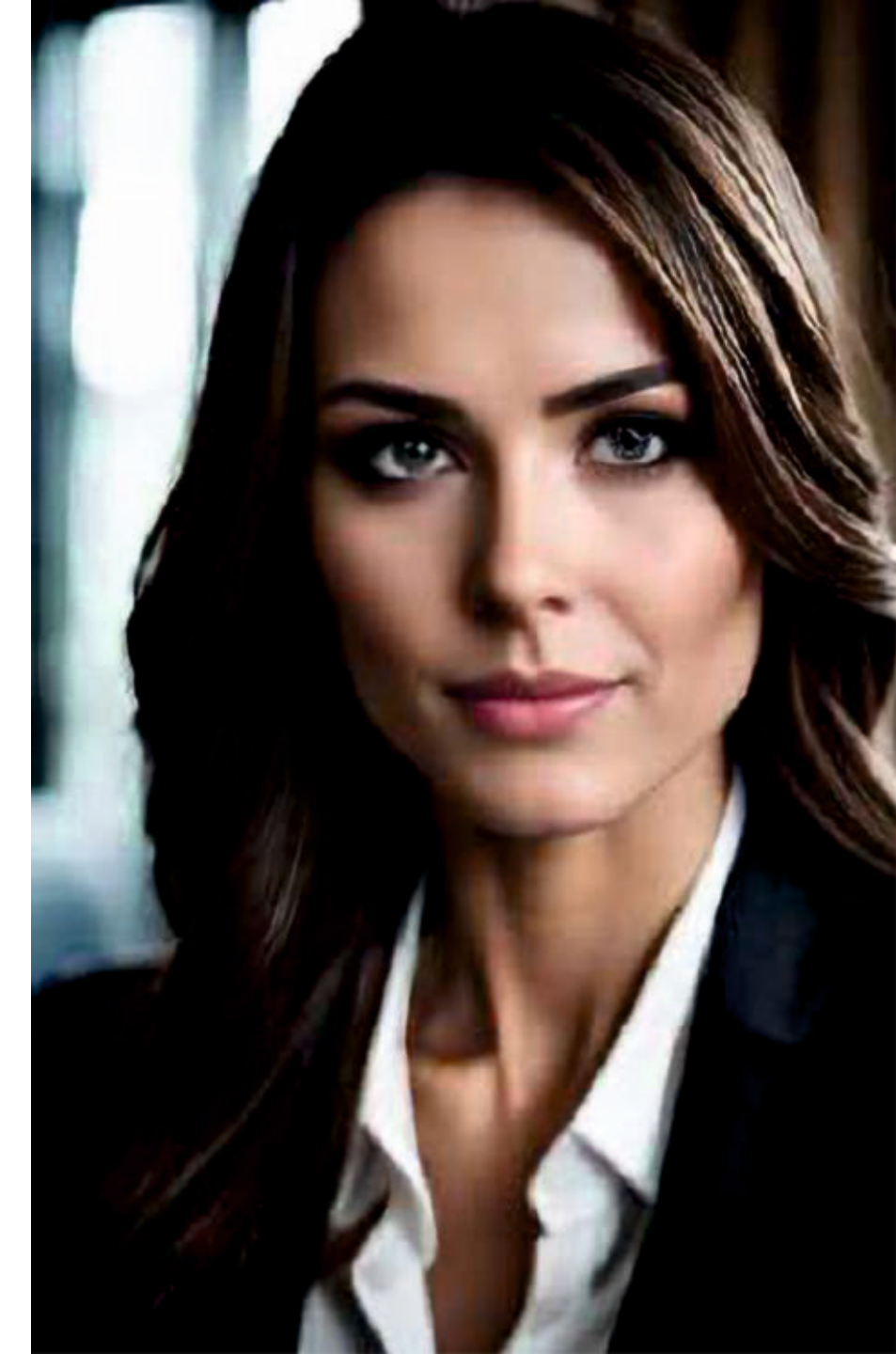


MAIN PROTAGONIST
